LIMITED POWER OF ATTORNEY FOR SECTION 16 REPORTING OBLIGATIONS

Know all by these presents, that the undersigned hereby constitutes and appoints each of Vincent A. Mercaldi and Tana L. Pool, signing singly, the undersigned's true and lawful attorney in fact to:
